

As required under Rule 22 of the Companies (Management and Administration) Rules, 2014 an advertisement was published by the Company in "BUSINESS STANDARD" in 'English' on 30<sup>th</sup> July, 2022 and "DHINATHANTHI" in vernacular language 'Tamil' on 30<sup>th</sup> July, 2022 informing about the despatch of the Postal Ballot Notice and other related matters mentioned therein. We have received E-Voting from the members during the period 1<sup>st</sup> August, 2022 (9:00 a.m. IST) to 30<sup>th</sup> August, 2022 (5:00 p.m. IST).

All the votes exercised upto the closure of working hours (**5:00 p.m. IST**) on Tuesday, 30<sup>th</sup> August, 2022, the last date fixed by the Company for receipt of E-Voting, were considered for our scrutiny.
