1. Tamil Nadu Newsprint and Papers Limited (hereinafter referred to as "TNPL") own and operates an integrated pulp and paper manufacturing facility at Kagithapuram (Unit I) and Mondipatti (Unit II) in the state of Tamil Nadu. The paper mill manufactures different varieties of paper and is one of the major producers of Printing & writing and Paper Boards in India.
2. TNPL plans to setup a 34,000 tpa Tissue paper manufacturing plant at its Unit II Mondipatti, Trichy District, Tamil Nadu.
3. TNPL invites sealed Bids for Design, engineering, manufacture, supply, installation and commissioning of a new Tissue Paper Machine of 2.850 meter deckle at Re-winder Reel suitable for manufacture of 34,000 tpa Tissue grades of substance ranging from 11 to 42 gsm and also for rendering supervisory services for erection, start-up, commissioning, training and for fulfilment of guaranteed performance of the Tissue Paper Machine for the proposed project.
2. TNPL invites Bids from eligible Bidders for Supply of New Tissue Paper Machine at TNPL Unit-II, as per the scope of this Bid Document through E-Procurement portal (<https://tntenders.gov.in/nicgep/app>).
3. The bidding procedure is electronic bid submission through the website (<https://tntenders.gov.in/nicgep/app>) only. The bidder can logon to this website and view the invitation for Bids and details of Materials / Works for which the bid is invited.

The Terms and Conditions for E-Tendering, Terms and Conditions for E-Reverse Auction and Process Compliance Statement are furnished as Appendix 1, Appendix 2 & Appendix 3 to Part 2 respectively.

4 **Qualification criteria**

- The bidder should be an internationally reputed manufacturer of Tissue Paper Machines and should have supplied at least five (5) complete new Tissue Paper Machines, with steel Yankee drying cylinder and having machine deckle  $\geq 2850$  mm, speed more than 1500 mpm that are capable of producing 100 TPD of various Tissue grades (Facial, Toilet, Napkin and Kitchen Towel), in the last ten (10) years, which are in successful operation.
- The annual turnover of bidder shall be not less than Euro 1000 million in each of the last three (3) completed financial years in pulp and paper sector.
- The supplier should have full time sales and service support office in India.

The bidder shall provide the documentary evidence for meeting the above qualification criteria.

**4. Bid Fee:**

A non-refundable fee of Rupees 25,000/- (inclusive of 18% GST) (or) USD \$ 280 (Or) Euro 270 should be remitted by the Bidder.

- Through RTGS/NEFT mode

(OR)

- by Demand Draft in favour of Tamil Nadu Newsprint and Papers Limited, payable at Trichy, Tamil Nadu, India.

**5. Bid Security**

The Bid must be accompanied by a Bid Security of Rs.25,00,000/- (Indian Rupees Twenty Five lakh only) (or) USD \$ 28,000 (US Dollars Twenty Eight Thousand only) (or) EURO 27,000 (Euro Twenty Seven Thousand only) .in one of the following forms.

- Through RTGS /NEFT mode.

(OR)

- An unconditional bank guarantee issued by a bank located in India, acceptable to TNPL in the form provided in the Bid Document.

(OR)

- A Demand Draft in favour of Tamil Nadu Newsprint and Papers Limited, payable at Trichy, Tamil Nadu, India.

6. The remittance details of both Bid Fee and Bid Security should also be furnished in the Technical cum Commercial Bid. Further scanned copy of DD / scanned copy of BG/ Remittance statement / UTR details should be uploaded in the online procurement portal: <https://tntenders.gov.in/nicgep/app>.

Bid Fee and Bid Security are not exempted, for any reason whatsoever.

Offers received without Bid Fee and EMD are liable for rejection. TNPL will not entertain any request for adjusting the EMD from the tenderer's due / running bills or from the EMD / Security Deposit of any other tender participated by the tenderer.

Bids shall be submitted, based on the guidelines set out in "Instructions to Bidders" enclosed as Part 2 of this Bid Document and shall be in conformity with the "General Terms and Conditions of Contract to be entered into between TNPL and the Successful Bidder" enclosed as Part 3 of this Bid Document and "Scope of Supply and Services" enclosed as Part 4 of this Bid Document
9. A two - stage two-cover (Stage 1 - Technical cover and Stage 2 – Final Technical + Finance cover) e-bidding procedure will be followed as below:

A two stage bidding procedure will be followed in NIC portal.

**STAGE 1**

- (i) Technical proposal shall be submitted by the bidders within the due date.
- (ii) Technical bids shall be opened on the due date.
- (iii) Upon scrutinizing the PQ documents, the bidders shall be qualified / rejected.
- (iv) Technical discussions shall be held with qualified bidders and final Scope / Technical Specification / BoQ arrived.
- (v) Technical evaluation shall be completed and bidders classified as qualified / rejected.

**STAGE 2**

- (vi) BoQ (Price in Sheet#1 & PG parameters in Sheet#2) will be uploaded for the frozen scope and sent to only bidders who got qualified in the 1st stage.
- (vii) Final Techno-commercial bid and Price bid BoQ (Price & PG parameters) shall be submitted by the qualified bidders within the due date.
- (viii) Price bids shall be opened on the due date including the PG parameters.
- (ix) The Price loading related to Performance guarantee parameters as applicable shall be applied to the quoted prices based on the best guaranteed values offered by the bidders and evaluated.
- (x) Evaluated L1 bidder shall be called for further discussions towards order finalization.
