- Tamil Nadu Newsprint and Papers Limited (hereinafter referred to as "TNPL") own and operates an integrated pulp and paper manufacturing facility at Kagithapuram in the state of Tamil Nadu. The paper mill manufactures different varieties of paper and is one of the major producers of newsprint and fine papers in India.
- For TNPL Unit I, as part of Revamping of Steam and Power System (RSPS #2), consultancy services as per the scope specified at Part 1 Annexure 1 in the Bid Document are to be carried out.

5 **Qualification Criteria:**

The bidder shall be a reputed consultant for obtaining statutory approvals and should meet the following Pre-qualification criteria:

The bidder should have been awarded order and successfully completed atleast **one such statutory approval** obtained from Site Appraisal Committee, Tamil Nadu Fire and Rescue Services and Public Health Department **in Tamil Nadu** to any reputed operating industrial establishments / Govt. departments / Corporations / Boards / undertakings in the **last Ten (10) years reckoned from December, 2014 (i.e., December 2014 to November 2024)**.

The bidder shall provide the documentary evidence for meeting the above qualification criteria.

6 Bid Fee:

A non-refundable fee of **Rupees 590/-** (inclusive of 18% GST) should be remitted by the Bidder through NIC online payment gateway.



7 EMD / Bid Security / Additional Security Deposit:

8 (a). EMD / Bid Security:

EMD / Bid Security of **Rs.20,000/-** (Indian Rupees Twenty thousand only) should be remitted by the Bidder through NIC online payment gateway.

(OR)

An unconditional bank guarantee issued by a bank located in India, acceptable to TNPL in the form provided in the Bid Document.

8 (b). Additional Security Deposit:

An Additional Security Deposit of **Rs.30,000/-** (Indian Rupees thirty thousand only) should be remitted by the Successful Bidder against award of Contract.

A Demand Draft / Bankers Cheque in favour of Tamil Nadu Newsprint and Papers Limited, payable at Karur, Tamil Nadu, India.

(OR)

If Bank Guarantee, an unconditional bank guarantee issued by a bank located in India, acceptable to TNPL in the form provided in the Bid Document (Part 2 – Appendix II) for a total value of Rs.50,000/- (Indian Rupees fifty thousand only) which includes EMD & Additional Security Deposit. In such case, Bank Guarantee submitted against EMD for a value of Rs.20,000/- (Indian Rupees Twenty thousand only) will be returned.

The Bank details for Payment will be informed to the successful Bidder.

The remittance details of both Bid Fee and EMD / Bid Security should also be furnished in the Technical cum Commercial Bid. Further scanned copy of Remittance statement / UTR details should be uploaded in the online procurement portal: https://tntenders.gov.in/nicgep/app.

Bid Fee and EMD / Bid Security are not exempted, for any reason whatsoever.

Offers received without Bid Fee and EMD / Bid security are liable for rejection. TNPL will not entertain any request for adjusting the EMD from the tenderer's due / running bills or from the EMD / Security Deposit of any other tender participated by the tenderer.
