- 1 Tamil Nadu Newsprint and Papers Limited (hereinafter referred to as "TNPL") own and operates an integrated pulp and paper manufacturing facility at Kagithapuram in the state of Tamil Nadu. The paper mill manufactures different varieties of paper and is one of the major producers of newsprint and fine papers in India.
- 2 For TNPL Unit I, Civil works as per the scope specified in the Bid Document is to be carried out.
- 3 TNPL invites Bids from Bidders for **"Renovation of RCC structures in Paper Machine No.3 area at TNPL Unit I"**, as per the scope of this Bid Document through E-Procurement portal (https://tntenders.gov.in/nicgep/app).
- 4 The bidding procedure is electronic bid submission through the website (https://tntenders.gov.in/nicgep/app) only. The bidder can logon to this website and view the invitation for Bids and details of works for which the bid is invited.

5 <u>EMD / Bid Security:</u>

EMD / Bid Security of **Rs.4,000/-** (Indian Rupees Four Thousand only) should be remitted by the Bidder through NIC online payment gateway.

Offers received without EMD / Bid security is liable for rejection. TNPL will not entertain any request for adjusting the EMD from the tenderer's due / running bills or from the EMD / Security Deposit of any other tender participated by the tenderer.

- 6 A single-cover (Finance cover) e-bidding procedure will be followed. For details, refer clause 11 of Appendix 1.
- 7 The due date for submission of EMD / Bid Security through E-procurement portal (<u>https://tntenders.gov.in/nicgep/app</u>) is before **3.00 pm on 24<sup>th</sup> January 2025**.

The Price Bids will be opened through online portal at **4:00 pm on 25<sup>th</sup> January 2025**.

8 TNPL will not be responsible for any delay in submission of online bid on the due date and time (Server time) through E-tendering portal <u>https://tntenders.gov.in/nicgep/app</u>.

TNPL reserves the right to split the order and award the contract to more than one bidder.
