- 1. Tamil Nadu Newsprint and Papers Limited (hereinafter referred to as "TNPL"), owns and operates a 4,00,000 tpa printing and writing paper mill at Kagithapuram (referred as "TNPL-Unit I") in the State of Tamil Nadu, India.
- TNPL intends to fix a contractor for Design, Manufacture, Supply, Packing & Forwarding of Steam Valves with IBR Test certificates for RSPS#2 Project at TNPL Unit – I, Kagithapuram, Karur.
- 3. TNPL invites Bids from eligible Bidders for Design, Manufacture, Supply, Packing & Forwarding of Steam Valves with IBR Test certificates for RSPS#2 Project at TNPL Unit I, Kagithapuram, Karur as per the scope of this Bid Document through E-Procurement portal (https://tntenders.gov.in/nicgep/app).
- 4. The bidding procedure is electronic bid submission through the website (https://tntenders.gov.in/nicgep/app) only. The bidder can logon to this website and view the invitation for Bids and details of Materials / Works for which the bid is invited.

The Terms and Conditions for E-Tendering, Terms and Conditions for E-Reverse Auction, Process Compliance Statement and Format for Bid Security BG and instruction for GST, E-invoice, E-way bill & MSME are furnished as Appendix 1, Appendix 2, Appendix 3, Appendix 4, Appendix 5 to Part 2 respectively.

5. Qualification Criteria

"The bidder shall be a reputed Indian manufacturer of Steam (IBR) valves having manufacturing and testing facility in their own works and should have executed at least two single orders for IBR steam valves of 2500# pressure rating with working temperature more than 525°C and value of each order not less than Rs.50 lakhs in the past five (5) years. Documentary Proof to this effect should be submitted by the bidder".

6. Bid Fee:

A non-refundable fee of **Rs. 1180/-** (inclusive of 18% GST) should be remitted by the Bidder through NIC online payment gateway.

7. Bid Security:

Bid Security of Rs.1,00,000/- (Rupees One Lakh only) should be remitted by the Bidder

> through NIC online payment gateway.

- An unconditional bank guarantee issued by a bank located in India, acceptable to TNPL in the form provided in the Bid Document.
- 8. The remittance details of both Bid Fee and Bid Security should also be furnished in the Technical Bid cum commercial bid. Further scanned copy of Remittance statement / UTR details should be uploaded in the online procurement portal: https://tntenders.gov.in/nicgep/app.

Bid Fee and Bid Security are not exempted, for any reason whatsoever.

Offers received without Bid Fee and bid security are liable for rejection. TNPL will not entertain any request for adjusting the bid security from the tenderer's due / running bills or from the EMD / Security Deposit of any other tender participated by the tenderer.

- 9. Bids shall be submitted, based on the guidelines set out in "Instructions to Bidders" enclosed as Part 2 of this Bid Document and shall be in conformity with the "General Terms and Conditions of Contract to be entered into between TNPL and the Successful Bidder" enclosed as Part 3 of this Bid Document and "Technical Specifications and Scope of Bid" enclosed as Part 4 of this Bid Document.
- 10. A two-cover (Technical cover and Finance cover) e-bidding procedure will be followed. For details, refer CI.11 of" Terms and Conditions for E-Tendering" enclosed as Appendix-1 to Part 2 of the Bid Document.
- 11. The due date for submission of Tender Documents including the Technical cum Commercial Bid along with Bid Fee / Bid Security and the Price bid through E-procurement portal (https://tntenders.gov.in/nicgep/app) is before 3:00 pm on 14th February 2025.

The Technical Bid will be opened in online portal at 4:00 pm on 15th February 2025.

Price Bids of those who qualify in Technical Bids will be opened in online portal at a later date, which will be informed to the qualified bidders. Subsequently, e-reverse auction will be conducted in online portal.
