The technical cum commercial bid will be scrutinized first and those who qualify in the technical cum commercial bid satisfying the tender conditions will only be considered for opening of PRICE BID. The date of opening of price bid will be communicated in due course and the price bids will be opened in the presence of interested bidders who choose to be present at the time of opening.

1. Tenderer should have supplied / harvested minimum 750 MT Wattle pulpwood (or) Bluegum pulpwood (or) in total of both Wattle & Bluegum from farmers fields / open market sources (Documentary proof should be enclosed)

2. Minimum quantity to be offered is 750 MT

# ANNEXURE - I - TERMS AND CONDITIONS:

<u>01.MATERIAL DESCRIPTION:</u> Debarked Bluegum pulpwood from open market sources of Tamil Nadu to TNPL Unit II, MONDIPATTI, TRICHY dist.

<u>02. QUANTITY: 1.508 MT.</u> The quantity given in the tender is only tentative and TNPL will not guarantee for the same.

#### 03. SPECIFICATIONS:

a) SIZE: Dia 2" and above.

LENGTH: 1.20 Mtrs to 1.50 Mtrs

#### **b) OTHER PARAMETERS:**

- The minimum diameter shall not be less than 2 inches.

- The maximum diameter shall not be more than 8 inches. Billets of diameter more than 8 inches are to be quartered by splitting and supplied.
- The supplies shall be free from crooked, twisted, bend and "Y" & "V" shaped billets.

Decayed / dead wood billets shall not be supplied.

#### c) INSPECTION:

- Wood billets of diameter less than 2" will be rejected and 5% of the total landed cost will be deducted for such supplies. In case the load contains substantial quantity of undersize material, the entire load will be rejected and sent back.
- Crooked, twisted and "Y" & "V" shaped and Decayed/dead wood billets if received shall be rejected totally and no payment shall be made for such quantity.
- In case billets of diameter exceeding 8" supplied, the cost of splitting/quartering shall be recovered from the contractor.

#### 04. QUALITY:

Quality is the essence of the tender. In the event of an order, the supplier should arrange to supply the material strictly as per our specifications given above.

The supply not conforming to the order specifications will be summarily rejected and no payment will be made for the rejected loads. The material rejected will not be returned to the supplier as it is not possible for TNPL to return the same and the supplier will have no right on such rejected loads. In this regard, the decision of TNPL will be final.

## **05. RATE:**

The rate is to be quoted on landed cost per MT basis with detailed break up i.e. Basic Price and GST as per the bidding schedule given as annexure - III.

#### 06. VALIDITY:

#### a) OFFER VALIDITY:

The rate quoted against the tender should be valid for acceptance for a minimum period of 60 days from the date of opening of price bid and during the validity period of the offer, no bidder is permitted to make any upward revision in the rate or withdraw his offer. In case of withdrawal or upward revision as stated above, the EMD / SD amount will be forfeited.

#### b) PRICE VALIDITY:

The rate finalized against the tender will be valid for a period of 6 months from the date of order.

#### **07. DELIVERY PERIOD:**

In the event of an order, the tenderer should be in a position to commence supplies immediately and supply minimum of 750MT/month. However, tenderer should complete the committed quantity in the span of 2 months.





## **08. PAYMENT:**

100% Payment will be made by RTGS within 5 days from the date of receipt of material subject to acceptance of invoice. RTGS charges will be to supplier's account.

## 09. EARNEST MONEY DEPOSIT (EMD):

- Bidders are required to pay an EMD @ Rs.1.00,000/- by Demand Draft as above. The EMD amount will not bear any interest.
- TNPL will not entertain any request for adjusting the EMD from the bidder's due/running bills or from the EMD/SD of any tender/enquiry participated by the bidder.
