The Board of Directors of **Tamil Nadu Newsprint and Papers Limited** vide resolution dated 28<sup>th</sup> May, 2019, pursuant to Section 108 and 109 of the Companies Act, 2013 read with Rule 20 (as amended) and 21 of the Companies (Management and Administration) Rules, 2014 have appointed us viz. 
